Call to Order: At 6:46 pm Mayor Crites Called the meeting to order and requested roll call.

Resolution 23-R-08 Approving a Public Finance Agreement between the Town of Frederick and Evergreen Devco, Inc. Assistant Town Manager Ryan Johnson presented the agreement.
