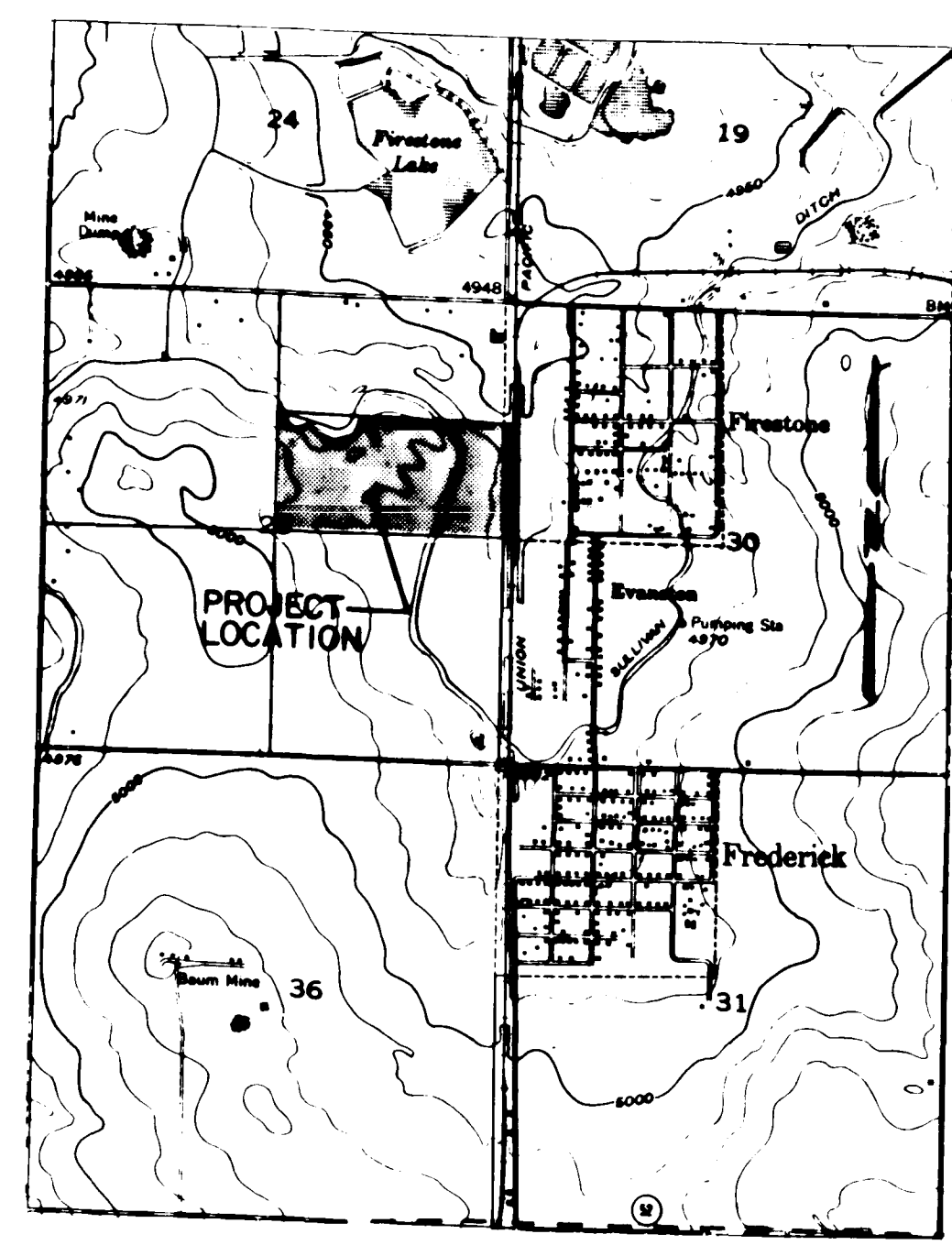

LEGAL DESCRIPTION ANNEXATION BOUNDARY

A PARCEL OF LAND SITUATED IN THE SOUTH ONE-HALF OF THE NORTHEAST ONE-QUARTER OF SECTION 25, TOWNSHIP 2 NORTH, RANGE 68 WEST OF THE 6TH PRINCIPAL MERIDIAN, COUNTY OF WELD, COLORADO AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE EAST ONE-QUARTER CORNER OF SAID SECTION 25, THENCE NORTH 89°20'09" WEST ALONG THE SOUTH LINE OF THE SOUTH ONE HALF OF THE NORTHEAST ONE-QUARTER OF SAID SECTION 25 A DISTANCE OF 30.00 FEET TO THE TRUE POINT OF BEGINNING.

THENCE CONTINUING NORTH 89°20'09" WEST A DISTANCE OF 2,603.43 FEET TO THE CENTER ONE-QUARTER CORNER OF SAID SECTION 25; THENCE NORTH 00°22'40" EAST ALONG THE WEST LINE OF THE SOUTH ONE-HALF OF THE NORTHEAST ONE-QUARTER OF SAID SECTION 25 A DISTANCE OF 1,319.47 FEET TO THE NORTHWEST CORNER OF THE SOUTH ONE HALF OF THE NORTHEAST ONE-QUARTER OF SAID SECTION 25; THENCE SOUTH 89°38'31" EAST ALONG THE NORTH LINE OF THE SOUTH ONE HALF OF THE NORTHEAST ONE-QUARTER OF SAID SECTION 25 A DISTANCE OF 38.20 FEET TO A POINT ON THE SOUTH LINE OF THE SOUTH PLATTE SUPPLY CANAL. 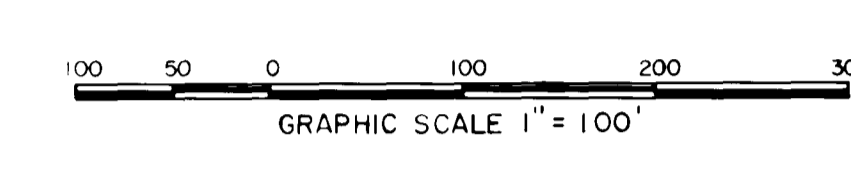
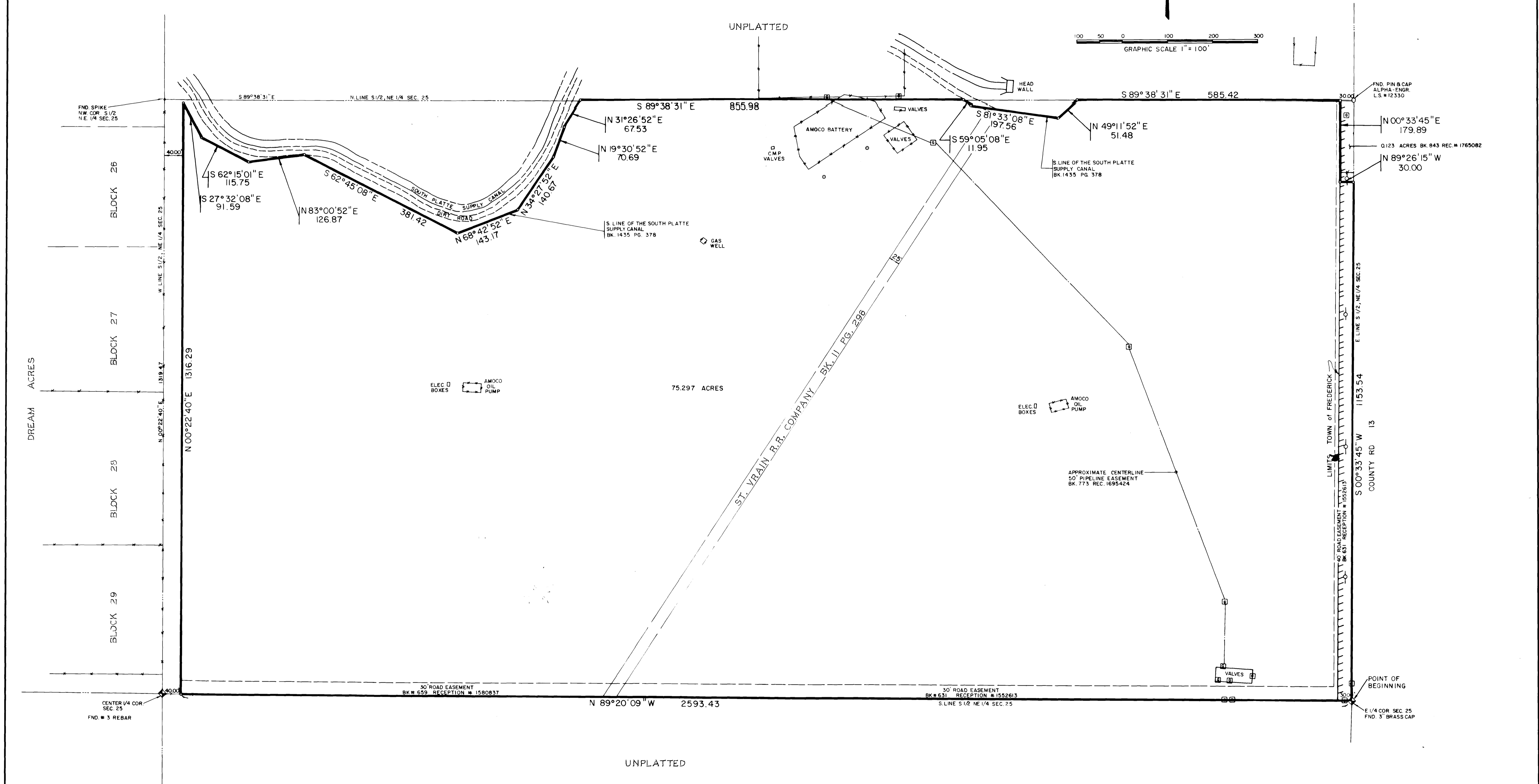
